## CLASSIFICATION OF PUBLICATIONS, FILMS AND COMPUTER GAMES REGULATIONS 1985

### Regulations under the *Classification Of Publications, Films And Computer Games Act 1985*

#### **1 Citation**

These Regulations may be cited as the *Classification of Publications, Films and Computer Games Regulations 1985*.

#### **2 Commencement**

These Regulations shall come into operation on the commencement of the *Classification of Publications Act 1985*.

#### **7 Display of sexual articles**

For section 102(3)(a) of the Act, a pharmacy business as defined in Schedule 7, clause 1 of the *Health Practitioners Act 2004* is a prescribed business.

#### **8 Exemptions**

For section 118(2) of the Act, the Charles Darwin University, the Alice Springs College of Technical and Further Education, Batchelor Institute, the Northern Territory Open College of Technical and Further Education, Katherine Rural College (known as the Northern Territory Rural College) and the Board of the Museum and Art Gallery of the Northern Territory are prescribed persons.
