Part 1 Preliminary

1 Citation

These Regulations may be cited as the *Gaming Control (Taxes and Levies) Regulations 2015*.

Part 2 Gaming machine community benefit levy

2 Meaning of applied provision

A reference in these Regulations to an **applied provision** is a reference to that provision of the *Gaming Machine Act 1995* as applied by section 35A of the *Gaming Control Act 1993*.

3 Prescribed day

- (1) For applied sections 144(1), 150(2), 152(1) and 153(1) and (2), the prescribed day in a month is the tenth business day in the month.
- (2) In this regulation:

business day means a day that is not a Saturday, Sunday or public holiday.

4 Prescribed manner of payment

For applied section 150(2), the prescribed manner of payment is the manner prescribed by the *Gaming Machine Regulations* 1995 for section 150(2) of the *Gaming Machine Act* 1995.

5 Prescribed percentage

For applied section 150(3), the prescribed percentage is 10%.

6 Penalty for late payment

- (1) For applied section 153(1)(a), the prescribed percentage is 5%.
- (2) For applied section 153(1)(b), the amount is to be credited in the following order of priority:
 - (a) firstly the gaming machine community benefit levy;
 - (b) secondly penalties under applied section 153(1)(a).
- (3) For applied section 153(2), the prescribed manner of payment is the manner prescribed by the *Gaming Machine Regulations* 1995 for section 153(2) of the *Gaming Machine Act* 1995.
