PLANT HEALTH (FEES) REGULATIONS 2012

Regulations under the *Plant Health Act 2008*

1 Citation

These Regulations may be cited as the *Plant Health (Fees) Regulations 2012*.

2 Fees

Schedule 1 prescribes the fees payable under the Act.

3 Exemption, waiver or refund of fees

The Chief Inspector may, if the Chief Inspector considers it appropriate, in relation to a prescribed fee:

- (a) exempt payment of the fee; or
- (b) waive (wholly or partly) payment of the fee; or
- (c) refund (wholly or partly) the fee.

Part 1 Ordinary fees

Item	Description	Section of Act	Fee (Revenue units)
1	Application for a permit to engage in an act otherwise prohibited under section 16(1)	16(2)	30
2	Application for inspection certificate	36	60
3	Application to be appointed as an accredited person for a plant health assurance scheme – if the application is made on or before the date specified in the scheme	41(1)	320
4	Application to be appointed as an accredited person for a plant health assurance scheme – if the application is made after the date specified in the scheme	41(1)	420
5	Audit by an inspector to verify compliance with conditions by an accredited person	42	60

Part 2 Additional fees as applicable in relation to items 2 and 5

Item	Description	Fee
1	Additional fee if travel is required to engage in the inspection or audit required (minimum ½ hour, and maximum 3 hours, per inspection or audit)	60 per hour
2	Additional fee if the inspection or audit is required to be carried out as overtime or emergency duty	in accordance with the rates and times specified in By-Law 37 of the <i>Public Sector Employment and Management By-Laws</i> as in force from time to time
