1 Citation

These Rules may be cited as the *Supreme Court (Absconding Debtors) Rules 1980*.

2 Application for warrant

For the purposes of section 5(2)(a) of the *Absconding Debtors Act 1978*, Form 1 is the prescribed form of application for a warrant.

3 Issue of warrant

For the purposes of section 6(3)(a) of the *Absconding Debtors Act 1978*, Form 2 is the prescribed form of warrant.

4 Application for order restraining transfer or removal of property

For the purposes of section 13(2) of the *Absconding Debtors Act* 1978, Form 3 is the prescribed form of application for an order restraining the transfer or removal of property.

5 Applications for review

For the purposes of section 20(2)(b) of the *Absconding Debtors Act 1978*, Form 4 is the prescribed form of application for review.
