Regulations under the *Community Based Sentences (Interstate Transfer) Act 2023*

1 Title

These Regulations may be cited as the *Community Based Sentences (Interstate Transfer) Regulations 2023*.

2 Commencement

These Regulations commence on the commencement of section 28 of the *Community Based Sentences (Interstate Transfer) Act 2023*.

3 Participating jurisdictions

For section 5 of the Act, definition *participating jurisdiction*, paragraph (b), each of the following is declared to be a participating jurisdiction:

- (a) the Australian Capital Territory;
- (b) New South Wales;
- (c) Queensland;
- (d) South Australia;
- (e) Tasmania;
- (f) Victoria;
- (g) Western Australia.
