## FOOD STANDARDS REGULATIONS

### Regulations under the *Food Act*

#### 1 Citation

These Regulations may be cited as the *Food Standards Regulations*.

#### 2 Commencement

These Regulations shall come into operation on the commencement of the *Food Act 1986*.

#### 3 Definition

In these Regulations, ***Food Standards Code*** means the Australia New Zealand Food Standards Code within the meaning of the *Australia New Zealand Food Authority Act 1991* of the Commonwealth.

#### 4 Code adopted as law of Territory

- (1) The Food Standards Code is hereby adopted as a law of the Territory, and shall have effect as if its provisions were regulations incorporated in these Regulations.
- (2) If there is conflict between a provision of the Food Standards Code and of the *Food (Interim Provisions) Regulations* or, as the case may be, the *Weights and Measures (Date-Marking of Pre-Packaged Foods) Regulations* in respect of the application of any of those provisions to food, the provision of the Food Standards Code shall prevail.
