### Regulations under the *Crimes (Victims Assistance) Act*

#### **1 Citation**

These Regulations may be cited as the *Crimes (Victims Assistance) (Notice of Payment) Regulations*.

#### **2 Commencement**

These Regulations shall come into operation on 20 April 1992.

#### **3 Notice of payment**

For the purposes of section 21(2) of the Act and to comply with Rule 6 of the *Local Court (Crimes (Victims Assistance)) Rules*, a notice of payment specifying the amount of assistance, costs and disbursements paid under section 20 of the Act shall be in accordance with Form 1.
