PORT (HANDLING OF DANGEROUS GOODS AND OILS) BY-LAWS

By-laws under the *Ports Act*

1 Application of A.A.P.M.A. Dangerous Goods Rules

- (1) Subject to this by-law, the Rules for the Handling of Dangerous Goods and Oils in Ports (other than Part 6 of and Appendix 2 to those Rules) published and endorsed by the Association of Australian Port and Marine Authorities, as amended to the date of commencement of these By-laws (hereinafter called *the Rules*) shall, with the necessary changes, apply to and in relation to the Port of Darwin as By-laws of the Port Corporation.
- (2) In the Rules *Marine Corporation* shall be read as *Port Corporation*.
- (3) In Rule 5.25 of the Rules **A.S.2117** shall be read as a reference to Australian Standard 2117 in relation to oil suction and discharge hoses.

2 Copies of the rules to be available

The harbourmaster shall make available at the office of the Port Corporation, for inspection or purchase by any person during normal business hours, copies of the Rules.
