## JUVENILE JUSTICE REGULATIONS

### Regulations under the *Justices Act*

#### **1 Citation**

These Regulations may be cited as the *Juvenile Justice Regulations*.

#### **2 Commencement**

These Regulations shall come into operation on the commencement of the *Community Welfare Act 1983*.

#### **3 Forms**

In these Regulations a reference to a form by number is a reference to a form so numbered in the Schedule.

#### **4 Orders of Court**

An order made under the Act by the Court shall be in accordance with Form 1.

#### **5 Complaints and informations**

A complaint made or information laid against a juvenile shall be in accordance with Form 2.

#### **6 Application under section 31(3)**

An application under section 31(3) of the Act shall be in accordance with Form 3.

#### **7 Warrant under section 42(2)**

A warrant referred to in section 42(2) of the Act shall be in accordance with Form 4.

#### **8 Application for further time to pay fine**

An application under section 54(1) of the Act for further time to pay a fine shall be in accordance with Form 5.

**9 Further time to pay fine**

The grant or refusal under section 54(1) of an application under that section shall be in accordance with Form 6.

**10 Appeal against refusal of further time to pay fine**

An appeal under section 54(2) of the Act shall be in accordance with Form 7.

**11 Affidavit of service**

An affidavit of service of a document required or permitted by the Act to be served shall be in accordance with Form 8.

**12 Application for Court to reconsider order**

An application referred to in section 61 of the Act shall be in accordance with Form 9.
