Interpretation Act

ADMINISTRATIVE ARRANGEMENTS ORDER

Ordered by His Honour the Administrator

- I, Thomas Ian Pauling, Administrator of the Northern Territory of Australia, acting with the advice of the Executive Council, for section 35 of the *Interpretation Act*, make the following orders commencing on 1 July 2008.
- All Administrative Arrangements Orders in force immediately before the date of this instrument cease to have effect.
- 2. Subject to any Act, the Minister holding a ministerial office specified in column 1 of Schedule 1 or 2 is allotted:
 - the general and financial administration of the Agencies specified in column 2 of that Schedule opposite the office to the extent that administration relates to the matters referred to in paragraphs (b) and (c); and
 - (b) the general and financial administration of:
 - (i) the Acts specified in column 3 of that Schedule opposite the office; and
 - (ii) any Acts not so specified relating to the principal areas of government for which the Minister is responsible; and
 - (c) the general and financial responsibility for the principal areas of government specified in column 4 of that Schedule opposite the office.
- 3. The departments and other Authorities and bodies specified in column 2 of Schedule 1 or 2 are nominated as Agencies.
- 4. Subject to any Act, an Agency specified in Schedule 1 is:
 - (a) an Agency for the *Public Sector Employment and Management Act*; and
 - (b) an Agency for the *Financial Management Act* unless clause 5 applies; and
 - (c) allotted the general and financial administration of:
 - (i) the Acts specified in column 3 of Schedule 1 opposite the Agency; and
 - (ii) any Acts not so specified relating to the principal areas of government for which the Agency is responsible; and

- except the financial administration of an Act allotted to another Agency by clause 5; and
- (d) allotted the general and financial responsibility for the principal areas of government specified in column 4 of Schedule 1 opposite the Agency except the financial responsibility for an area allotted to another Agency by clause 5.
- 5. Subject to any Act, an Agency specified in Schedule 2 is:
 - (a) an Agency for the Financial Management Act only; and
 - b) allotted the financial administration of:
 - the Acts specified in column 3 of Schedule 2 opposite the Agency; and
 - (ii) any Acts not so specified relating to the principal areas of government for which the Agency has financial responsibility; and
 - (c) allotted the financial responsibility for the principal areas of government specified in column 4 of Schedule 2 opposite the Agency.
