## COMPANIES (TRUSTEES AND PERSONAL REPRESENTATIVES) REGULATIONS

### Regulations under the *Companies (Trustees and Personal Representatives) Act*

#### **1 Citation**

These Regulations may be cited as the *Companies (Trustees and Personal Representatives) Regulations*.

#### **2 Forms**

- (1) In these Regulations, a reference to a form by number shall be read as a reference to the form so numbered in the Schedule.
- (2) A form in the Schedule shall be completed in accordance with such directions and instructions as are specified in the form.

#### **3 Declarations by trustee companies**

For the purposes of section 13(1) of the Act, a statutory declaration shall be in accordance with Form 1.
