PETROLEUM PRODUCTS SUBSIDY REGULATIONS

Regulations under the Petroleum Products Subsidy Act

1 Citation

These Regulations may be cited as the *Petroleum Products Subsidy Regulations*.

2 Claims for payment

For the purposes of section 13 of the Act a claim by a registered distributor of eligible petroleum products under that Act shall:

- (a) be on a form made available by an authorised officer for the purpose;
- (b) include the information required by the form;
- (c) be signed by the distributor or by a person authorised by the distributor;
- (d) be accompanied by a summary of the sales of eligible petroleum products to which the claim relates; and
- (e) be sent by post to, or lodged at, the Office of Regional Director, AusIndustry, Department of Industry, Science and Resources of the Commonwealth in Brisbane.
