## DARWIN RATES REGULATIONS

### Regulations under the *Darwin Rates Act*

#### **1 Citation**

These Regulations may be cited as the *Darwin Rates Regulations*.

#### **2 Interpretation**

- (1) In these Regulations ***the Act*** means the *Darwin Rates Act*.
- (2) In these Regulations a reference to a form by number shall be read as a reference to the form so numbered in Schedule 1.

#### **3 Compliance with forms**

Strict compliance with the forms in Schedule 1 is not necessary and substantial compliance is sufficient.

#### **4 Application to have name entered in rate book**

For the purposes of section 7 of the Act, an application to have the name of a person entered in the rate book as owner or occupier, as the case may be, of ratable land shall be in accordance with Form 1.

#### **5 Application to have name removed from rate book**

For the purposes of section 7 of the Act, an application to have the name of a person removed from the rate book as owner or occupier, as the case may be, of ratable land shall be in accordance with Form 2.

#### **6 Particulars in rate book**

The Minister shall cause to be entered in the rate book particulars of rates levied on each parcel of ratable land within the prescribed area, and fines added to those rates, any rates or fines paid, any such rates or fines written off and any arrears of such rates.

**7 Form of rate notice**

A rate notice shall be in accordance with Form 3.

**8 Notice of appeal against entry in rate book**

For the purposes of section 18 of the Act, a notice of appeal against an entry in the rate book shall be in accordance with Form 4.

**9 Notice of appeal against omission of name from rate book**

For the purposes of section 18 of the Act, a notice of appeal against the omission of a name from the rate book shall be in accordance with Form 5.

**10 Prescribed area**

So much of the area referred to or described in Schedule 2 as is not within a municipality is the prescribed area for the purposes of the Act.
