RECORDS OF DEPOSITIONS REGULATIONS

Regulations under the *Records of Depositions Act*

1 Citation

These Regulations may be cited as the *Records of Depositions Regulations*.

2 Commencement

The Regulations shall come into operation on the commencement of the *Records of Depositions Amendment Act 1983*.

3 Fees

For section 13(1) of the Act, the fees for the provision of a copy of the depositions of a witness in a proceeding before the court are as follows:

- (a) for a copy of a transcript of the record or the record (not being a copy certified by writing under the hand of the clerk of the relevant court to be a true copy) – an amount calculated at the rate of 14 revenue units per page of typewritten copy; and
- (b) for a copy of a transcript of the record or the record certified by writing under the hand of the clerk of the relevant court to be a true copy – an amount calculated at the rate of 14 revenue units per page of typewritten copy and in addition 10 revenue units.
