## MUSEUM AND ART GALLERY OF THE NORTHERN TERRITORY REGULATIONS 2014

### Regulations under the *Museum and Art Gallery of the Northern Territory Act 2014*

#### 1 Citation

These Regulations may be cited as the *Museum and Art Gallery of the Northern Territory Regulations 2014*.

#### 2 Commencement

These Regulations commence on the commencement of the *Museum and Art Gallery of the Northern Territory Act 2014*.

#### 3 Grounds and facilities of Museum and Art Gallery of the Northern Territory

For section 7 of the Act, the grounds and facilities of the Museum and Art Gallery of the Northern Territory are:

- (a) those specified in the Schedule, Part A; and
- (b) the following grounds and facilities (known as the **Chan Art Gallery**) located in the Chan Building at 16 Mitchell Street, Darwin City, Lot No. 7419:
  - (i) the portion of the ground floor shown shaded on the plan in the Schedule, Part B;
  - (ii) level 1;
  - (iii) level 2.
