## AN ACT

to make interim provision for the issuing and expending of public moneys of the Territory for the year ending 30 June 2006

[Assented to 30 June 2005]  
[Second reading 30 June 2005]

**The Legislative Assembly of the Northern Territory enacts as follows:**

**1. Short title**

This Act may be cited as the *Supply Act 2005-2006*.

**2. Authorisation and allocation of \$202 867 000**

Allocations of the public moneys of the Territory, amounting in aggregate to \$202 867 000, are authorised to be paid from the Central Holding Authority to the Purposes specified in the Schedule for the year ending on 30 June 2006.
