AN ACT

to amend various legislative provisions consequential on the enactment of the
Mining Management Act

[Assented to 19 July 2001]
[Second reading 5 July 2001]

The Legislative Assembly of the Northern Territory enacts as follows:

1. Short title

This Act may be cited as the *Mining Management (Consequential Amendments) Act 2001*.

2. Commencement

This Act comes into operation on the commencement of the *Mining Management Act 2001*.

3. Amendment of *Work Health Act*

Section 28A of the *Work Health Act* is omitted and the following substituted:

"28A. Part not to apply to mining site or mining activity

"This Part does not apply in relation to –

- (a) a mining site within the meaning of the *Mining Management Act*;
or

Mining Management (Consequential Amendments) Act 2001

- (b) work or services performed in relation to a mining activity within the meaning of the *Mining Management Act*."

4. Amendments of Work Health (Occupational Health and Safety) Regulations

(1) Regulation 3 of the Work Health (Occupational Health and Safety) Regulations is omitted and the following substituted:

"3. Regulations not to apply to mining site or mining activity

"These Regulations do not apply in relation to –

- (a) a mining site within the meaning of the *Mining Management Act*; or
(b) work or services performed in relation to a mining activity within the meaning of the *Mining Management Act*."

(2) The Regulations amended by subsection (1) may be amended or repealed by regulation as if the amendment had been made by regulation.

5. Further amendments

The Acts specified in the Schedule are amended as set out in that Schedule.
