# NORTHERN TERRITORY OF AUSTRALIA

## AN ACT

to amend the *Corporations (Northern Territory) Act*

[Assented to 29 June 2001]  
[Second reading 6 June 2001]

**The Legislative Assembly of the Northern Territory enacts as follows:**

**1. Short title**

This Act may be cited as the *Corporations (Northern Territory) Amendment Act 2001*.

**2. Commencement**

This Act is to be taken to have come into operation on 24 November 2000.

**3. Principal Act**

The *Corporations (Northern Territory) Act* is in this Act referred to as the Principal Act.

**4. Definitions**

Section 3 of the Principal Act is amended –

- (a) by omitting from paragraph (b) of the definition of "applicable provision" in subsection (1) "ASC" (twice occurring) and substituting "ASIC";
- (b) by omitting from subsection (1) the definitions of "ASC Act", "ASC Law", "ASC Law of the Northern Territory", "ASC Regulations" and

"ASC Regulations of the Northern Territory" and substituting the following:

" 'ASIC Act' means the *Australian Securities and Investment Commission Act 1989* of the Commonwealth;

'ASIC Law' has the same meaning as in Part 11;

'ASIC Law of the Northern Territory' means the provisions applying by reason of section 58;

'ASIC Regulations' has the same meaning as in Part 11;

'ASIC Regulations of the Northern Territory' means the provisions applying by reason of section 59;";

- (c) by omitting from subsection (1) the definition of "Commission" and substituting the following:

" 'Commission' means the Australian Securities and Investment Commission established by the ASIC Act;";

- (d) by omitting from the definition of "Commonwealth law" in subsection (1) "ASC" and substituting "ASIC";

- (e) by omitting from paragraph (c) of the definition of "corresponding law" in subsection (1) "ASC" (twice occurring) and substituting "ASIC"; and

- (f) by omitting from paragraph (c) of the definition of "national scheme law of this jurisdiction" in subsection (1) "ASC" and substituting "ASIC".

**5. Corporations Law of the Northern Territory**

Section 15 of the Principal Act is amended by inserting after subsection (1) the following:

"(1A) Chapters 6, 6A, 6B, 6C and 6D of the Corporations Law of Northern Territory—

- (a) bind the Crown in right of the Commonwealth in so far as the legislative power of the Legislative Assembly permits; and
- (b) do not bind the Crown in right of the Northern Territory, any State, the Capital Territory or Norfolk Island."

**6. Interpretation of some expressions in ASIC Law and ASIC Regulations of the Northern Territory**

Section 60 of the Principal Act is amended—

*Corporations (Northern Territory) Amendment Act 2001*

- (a) by omitting from subsection (1) "in the ASC Law, and the ASC Regulations," and substituting "in the ASIC Law, and the ASIC Regulations,";
- (b) by omitting from the definition of "Advisory Committee" in subsection (1) "ASC" and substituting "ASIC";
- (c) by omitting from the definition of "affairs" in subsection (1) "260" and substituting "264AA";
- (d) by omitting from the definition of "assist" in subsection (1) "ASC" (twice occurring) and substituting "ASIC";
- (e) by omitting from the definition of "Australia" in subsection (1) "ASC" and substituting "ASIC";
- (f) by omitting from paragraph (b) of the definition of "books" in subsection (1) "accounts or accounting records" and substituting "financial reports or financial records";
- (g) by omitting from paragraph (a) of the definition of "Chairperson" in subsection (1) "ASC" and substituting "ASIC";
- (h) by omitting from subsection (1) the definition of "Commission" and substituting the following:

" 'Commission' means the Australian Securities and Investment Commission established by section 7 of the ASIC Act;"
- (i) by omitting from the definitions of "Commission delegate", "court" and "Disciplinary Board" in subsection (1) "ASC" and substituting "ASIC";
- (j) by omitting from the definition of "examination" in subsection (1) "ASC" (wherever occurring) and substituting "ASIC";
- (k) by omitting from the definition of "expenses" in subsection (1) "ASC" (twice occurring) and substituting "ASIC";
- (l) by omitting from the definitions of "foreign country", "give", "hearing", "meeting", and "member" in subsection (1) "ASC" and substituting "ASIC";
- (m) by omitting from the definition of "national scheme law" in subsection (1) "ASC" (twice occurring) and substituting "ASIC";
- (n) by omitting from the definitions of "national scheme law of this jurisdiction" and "Panel" in subsection (1) "ASC" and substituting "ASIC";
- (o) by inserting after the definition of "Panel" in subsection (1) the following:

"Panel proceedings' means the proceedings before the Panel on –

- (a) an application made to the Panel under the Corporations Law; or
- (b) a reference of a decision of the Panel for review under the Corporations law;"
- (p) by omitting from the definitions of "prescribed", "produce", "record", "regulations", "staff member", "Territory" and "this Act" in subsection (1) "ASC" and substituting "ASIC";
- (q) by omitting from subsection (1) the definition of "witness" and substituting the following:

" 'witness means' –

- (a) in relation to a hearing before the Commission – a person appearing at the hearing to give evidence; or
- (b) in relation to Panel proceedings – a person appearing in the proceedings to give evidence;"
- (r) by omitting from subsection (2) "ASC" (twice occurring) and substituting "ASIC".

**7. Certain transfers by companies under *Land Title Act* not to constitute reduction of share capital**

Section 95 of the Principal Act is amended –

- (a) by omitting "Where" and substituting "(1) Where"; and
- (b) by adding at the end the following:

"(2) Subsection (1) does not apply to a transfer made on or after the commencement of this Act."

**8. Further amendments**

The Principal Act is amended as set out in the Schedule.

- (b) the headings to sections 63, 64 and 65 are altered by omitting "ASC" (twice occurring) and substituting "ASIC".
