AN ACT

to revise and correct the law of the Territory in minor respects

[Assented to 18 June 1999]
[Second reading 27 April 1999]

The Legislative Assembly of the Northern Territory enacts as follows:

1. Short title

This Act may be cited as the *Statute Law Revision Act 1999*.

2. Commencement

Section 7(2) comes into operation on the date on which the assent of the Administrator to this Act is declared or the date on which the *Mining Amendment Act (No. 3) 1998* commences, whichever is the later.

3. Amendment of *Bail Act*

Section 40 of the *Bail Act* is amended by omitting from subsection (2) "Notwithstanding section 4(1) of the *Claims by and against the Government Act*, where" and substituting "If".

4. Amendment of Criminal Code

(1) Section 186A of the Criminal Code is amended—

(a) by omitting paragraph (a) of the definition of "authorised professional" and substituting the following:

- "(a) a person who is a registered nurse within the meaning of the *Nursing Act*"; and
- (b) by omitting "Nurses Board" from paragraph (b) of the definition of "authorised professional" and substituting "Nursing Board of the Northern Territory".

(2) Section 441 of the Criminal Code is amended by inserting after subsection (2) the following:

"(2A) A reference in subsection (2) to a member of the Police Force does not include a person who has not taken an oath or made an affirmation under section 26 of the *Police Administration Act*."

5. Amendment of *Juries Act*

(1) Section 29 of the *Juries Act* is amended by omitting all the words after "summons" and substituting "in a form approved by the Sheriff".

(2) Schedule 4 to the *Juries Act* is repealed.

6. Amendment of *Medical Act*

(1) Section 3 of the *Medical Act* is amended by omitting from the definition of "Chief Health Officer" in subsection (1) "*Public Health Act*" and substituting "*Public Health Act* and includes his or her nominee".

(2) Section 5 of the *Medical Act* is amended –

- (a) by inserting in subsection (1)(a) "or his or her nominee" after "Chief Health Officer"; and
- (b) by adding at the end the following:

"(3) A nominee of the Chief Health Officer is to be a person who is registered or entitled to be registered."

7. Amendment of *Mining Act*

(1) Section 110 of the *Mining Act* is amended by omitting from subsection (4) "A person on whom a notice is served under section 108(h) may," and substituting "A person referred to in section 108(h) or (ha) on whom a notice is served under subsection (1) may,".

(2) Section 163 of the *Mining Act* is amended –

- (a) by omitting from subsection (1)(d) ", exploration retention licence"; and

- (b) by omitting from subsection (1)(g) "at the office of the Secretary" and substituting "with the Department".

8. Amendment of *Optometrists Act*

Section 6 of the *Optometrists Act* is amended –

- (a) by omitting from subsection (1) "Chief Health Officer" and substituting "Chairman";
- (b) by inserting in subsection (2) "or his or her nominee" after "Chief Health Officer"; and
- (c) by adding at the end the following:

"(7) A nominee of the Chief Health Officer is to be a person who is registered, or entitled to be registered, as a medical practitioner under the *Medical Act*".

9. Amendment of *Pharmacy Act*

(1) Section 7 of the *Pharmacy Act* is amended –

- (a) by omitting from subsection (1)(a) "Chief Health Officer" and substituting "Chairman";
- (b) by inserting in subsection (3) "or his or her nominee" after "Chief Health Officer"; and
- (c) by adding at the end the following:

"(7) A nominee of the Chief Health Officer is to be a person who is registered, or entitled to be registered, as a medical practitioner under the *Medical Act*".

(2) Section 16 of the *Pharmacy Act* is amended by omitting from subsection (2) "Consolidated Fund" and substituting "Public Account, within the meaning of the *Financial Management Act*, in accordance with that Act".

10. Amendment of *Poisons and Dangerous Drugs Act*

(1) Section 29 of the *Poisons and Dangerous Drugs Act* is amended by omitting subsection (4A) and substituting the following:

"(4A) A registered nurse within the meaning of the *Nursing Act* who is approved, or is a member of a class of registered nurses approved, by the Chief Health Officer by notice in the *Gazette* may possess and supply a Schedule 1, 2, 3, 4 or 8 substance –

- (a) in the course of his or her duties; and
- (b) if the notice specifies or refers to a protocol for dealing with a substance specified in the notice – in accordance with the protocol."

(2) Section 59 of the *Poisons and Dangerous Drugs Act* is amended –

- (a) by omitting from subsection (1)(a) "section 55" and substituting "section 53 or 55";
- (b) by inserting in subsection (1)(b) "an authorisation granted under this Part or" before "a licence";
- (c) by inserting in subsection (1)(d) "grant an authorisation or to" after "refuse to"; and
- (d) by omitting from subsection (1)(e) "period," and substituting "period an authorisation or".

(3) Section 86 of the *Poisons and Dangerous Drugs Act* is amended by omitting ", the Regulations or the *Containers for Hazardous Substances Act* shall" and substituting "or the Regulations must".

11. Amendment of *Radiographers Act*

Section 4 of the *Radiographers Act* is amended –

- (a) by inserting in subsection (2)(a) "or his or her nominee" after "Chief Health Officer"; and
- (b) by adding at the end the following:

"(4) A nominee of the Chief Health Officer is to be a person who is registered, or entitled to be registered, as a medical practitioner under the *Medical Act*."

12. Amendment of *Traffic Regulations*

(1) Regulation 58 of the *Traffic Regulations* is amended by inserting in subregulation (1) "(including a police station)" after "such other place".

(2) Regulation 58 of the *Traffic Regulations* may be repealed or further amended by a regulation made under the *Traffic Act* as if the amendment effected by subsection (1) had been made by a regulation under that Act.

13. Amendment of *Waste Management and Pollution Control Act*

Section 117 of the *Waste Management and Pollution Control Act* is amended by omitting from subsection (2)(k) "prescribe" and substituting "prescribe, other than in relation to an environmental offence within the meaning of the *Environmental Offences and Penalties Act*,".

14. Amendment of Workman's Liens Regulations

Form 1 in the Schedule to the Workman's Liens Regulations is amended by omitting from the Schedule of Notes all words in item 10 from and including "Persons who may witness" to and including "under the *Oaths Act* (N.T.)."

15. Revision of other Acts

The Acts specified in Schedule 1 are amended as set out in that Schedule.

16. Revision of other Regulations

(1) The Regulations specified in Schedule 2 are amended as set out in that Schedule.

(2) A regulation amended as set out in Schedule 2 may be amended or repealed by a regulation as if the amendment had been made by a regulation.
