AN ACT

to authorise the issuing and expending of public moneys of the Territory in respect of the year ending 30 June 2000

[Assented to 22 June 1999]

[Second reading 1999]

The Legislative Assembly of the Northern Territory enacts as follows:

1. Short title

This Act may be cited as the *Appropriation Act 1999-2000*.

2. Commencement

This Act comes into operation on 1 July 1999.

3. Authorisation and Allocation of \$2,997,917,000

Allocations of the public moneys of the Territory, amounting in aggregate to \$2,997,917,000, are available for expenditure on the Activities specified in the Schedule in respect of the year ending on 30 June 2000.
