Act No. 27 of 2011

An Act to amend penalties in various Acts administered by the Chief Minister and Minister for Police, Fire and Emergency Services, and for other purposes

The Legislative Assembly of the Northern Territory enacts as follows:

1 Short title

This Act may be cited as the *Penalties Amendment (Chief Minister's and Other Portfolios) Act 2011.*

2 Commencement

This Act commences on the day fixed by the Administrator by *Gazette* notice.
