NORTHERN TERRITORY OF AUSTRALIA

Act No. 38 of 2010

An Act to amend penalties in various Acts and subordinate legislation administered by the Minister for Justice and Attorney-General, Minister for Racing, Gaming and Licensing and Treasurer

[Assented to 18 November 2010] [Second reading 19 August 2010]

The Legislative Assembly of the Northern Territory enacts as follows:

1 Short title

This Act may be cited as the *Penalties Amendment (Justice and Treasury Legislation) Act 2010.*

2 Commencement

This Act commences on the day fixed by the Administrator by *Gazette* notice.
