NORTHERN TERRITORY OF AUSTRALIA

Act No. 41 of 2003

AN ACT

to amend various legislation consequential on the enactment of the *Commercial Passenger (Road) Transport Amendment Act (No. 2) 2003*

[Assented to 7 July 2003]
[Second reading 25 February 2003]

The Legislative Assembly of the Northern Territory enacts as follows:

1. Short title

This Act may be cited as the *Commercial Passenger (Road) Transport (Consequential Amendments) Act 2003*.

2. Commencement

The provisions of this Act come into operation on the dates, or respective dates, fixed by the Administrator by notice in the *Gazette*.

3. Amendments of *Motor Vehicles Act*

(1) Section 5 of the *Motor Vehicles Act* is amended by inserting after the definition of "licensee" in subsection (1) the following:

"limousine" has the same meaning as in the *Commercial Passenger (Road) Transport Act*;

(2) Section 10 of the *Motor Vehicles Act* is amended by omitting from subsection (1) "motor omnibus, taxi or private hire car, tourist vehicle, special passenger vehicle, minibus" and substituting "commercial passenger vehicle".

Commercial Passenger (Road) Transport (Consequential Amendments) Act 2003

(3) Section 19 of the *Motor Vehicles Act* is amended by omitting from subsection (1) ", supplementary taxis".

(4) Section 22 of the *Motor Vehicles Act* is amended by omitting from subsection (2) "taxi, private hire car, motor omnibus, tourist vehicle, minibus or special passenger vehicle" and substituting "commercial passenger vehicle".

4. Amendment of *Stamp Duty Act*

Schedule 2 to the *Stamp Duty Act* is amended by omitting from item 33A "or a supplementary taxi licence".

5. Amendments of *Tobacco Control Act*

Section 5 of the *Tobacco Control Act* is amended –

(a) by inserting after the definition of "child" the following:

" 'commercial passenger vehicle' has the same meaning as in the *Commercial Passenger (Road) Transport Act*"; and

(b) by omitting "bus, taxi, private hire car" from the definition of "public transport" and substituting "commercial passenger vehicle".

6. Amendments of Regulations

(1) The Regulations specified in the Schedule are amended as set out in that Schedule.

(2) A regulation amended as set out in the Schedule may be amended or repealed by a regulation as if the amendment had been made by a regulation.
