

## NORTHERN TERRITORY OF AUSTRALIA

No. 28 of 1997

# AN ACT

#### to authorise the issuing and expending of the public moneys of the Territory in respect of the year ending 30 June 1998

#### [Assented to 27 June 1997]

**B** it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the Northern Territory (Self-Government) Act 1978 of the Commonwealth, as follows:

1. SHORT TITLE

This Act may be cited as the Appropriation Act 1997-98.

2. COMMENCEMENT

This Act comes into operation on 1 July 1997.

3. ALLOCATIONS AND APPLICATION OF \$2,747,091,000

Allocations of the public moneys of the Territory, amounting in aggregate to \$2,747,091,000, are available for expenditure on the Activities specified in the Schedule in respect of the year ending on the expiration of 30 June 1998.
