# AN ACT

to revise and correct the law of the Territory in minor aspects

[Assented to 17 September 1996]

**B**E it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the Northern Territory (Self-Government) Act 1978 of the Commonwealth, as follows:

#### 1. SHORT TITLE

This Act may be cited as the Statute Law Revision Act 1996.

#### 2. REPEAL

The Mining Development Ordinance 1939 (No. 5 of 1939) and the Mining Development Ordinance 1940 (No. 7 of 1940) are repealed.

#### 3. AMENDMENT OF LIQUOR ACT

Section 4 of the *Liquor Act* is amended by adding at the end the following:

"(2) Unless the contrary intention appears, a reference in this Act to a person employed by a licensee includes a reference to a person whose services are provided to a licensee under a contract with the person or another person.".

#### 4. AMENDMENTS OF LOCAL GOVERNMENT ACT

(1) The Local Government Act is in this section referred to as the Principal Act.

- (2) Section 3 of the Principal Act is amended by omitting from the definition of "special meeting" the words "section 59" and substituting "section 52".
- (3) Section 9(1) of the Principal Act is amended by omitting paragraph (h).
- (4) Section 11(1)(e) of the Principal Act is amended by omitting "(other than a notice of resignation under section 13)".
- (5) Section 97(1)(q) of the Principal Act is amended by omitting "the community government area" and substituting "a council meeting".
- (6) Section 198(1)(b) of the Principal Act is amended by omitting "municipality" and substituting "council area".
- (7) Section 205(4)(b) of the Principal Act is amended by omitting "identify" and substituting "identity".
- (8) The amendments effected by subsections (3) and (4) shall be deemed to have come into operation on the commencement of the Northern Territory Electoral Act.

#### 5. AMENDMENT OF MISUSE OF DRUGS ACT

Section 19A of the Misuse of Drugs Act is amended -

- (a) by omitting from paragraph (a) of the definition of "minimum amount" the word "or";
- (b) by omitting from paragraph (b) of that definition
  "1 g.;" and substituting "1 g.; or"; and
- (c) by adding at the end of that definition the following:
- "(c) in relation to cannabis, 5 plants.".

### 6. REVISION OF OTHER ACTS

The provisions of the Acts specified in the Schedule are amended as provided for in that Schedule.
