B^E it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the Northern Territory (Self-Government) Act 1978 of the Commonwealth, as follows:

1. SHORT TITLE

This Act may be cited as the Trustee (Consequential Amendments) Act 1996.

2. COMMENCEMENT

This Act shall come into operation, or shall be deemed to have come into operation, on the commencement of the Trustee Amendment Act (No. 2) 1995.
