AN ACT

to amend various Acts and Regulations consequential on the passing of the Conservation Commission

Amendment Act 1995

[Assented to 15 November 1995]

B^E it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the Northern Territory (Self-Government) Act 1978 of the Commonwealth, as follows:

1. SHORT TITLE

This Act may be cited as the Parks and Wildlife Commission (Consequential Amendments) Act 1995.

2. COMMENCEMENT

This Act shall come into operation on the commencement of the Conservation Commission Amendment Act 1995.

3. AMENDMENTS TO ACTS

The provisions of the Acts specified in Schedule ${\bf 1}$ are amended as provided for in the Schedule.

4. AMENDMENTS TO OZONE PROTECTION REGULATIONS

- (1) The Ozone Protection Regulations are amended as provided for in Schedule 2.
- (2) A regulation amended by subsection (1) may be repealed or further amended as if the amendments made by that subsection were made by amending regulations.
