AN ACT

to amend various Acts and Regulations consequential
on the passing of the *Conservation Commission
Amendment Act 1995*

[Assented to 15 November 1995]

BE it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the *Northern Territory (Self-Government) Act 1978* of the Commonwealth, as follows:

1. SHORT TITLE

This Act may be cited as the *Parks and Wildlife Commission (Consequential Amendments) Act 1995*.

2. COMMENCEMENT

This Act shall come into operation on the commencement of the *Conservation Commission Amendment Act 1995*.

3. AMENDMENTS TO ACTS

The provisions of the Acts specified in Schedule 1 are amended as provided for in the Schedule.

4. AMENDMENTS TO OZONE PROTECTION REGULATIONS

(1) The Ozone Protection Regulations are amended as provided for in Schedule 2.

(2) A regulation amended by subsection (1) may be repealed or further amended as if the amendments made by that subsection were made by amending regulations.
