



NORTHERN TERRITORY OF AUSTRALIA

No. 6 of 1995

AN ACT

to authorise the issuing and expending of the public moneys of the Territory in respect of the year ending 30 June 1995

[Assented to 22 March 1995]

BE it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the *Northern Territory (Self-Government) Act 1978* of the Commonwealth, as follows:

1. SHORT TITLE

This Act may be cited as the *Appropriation Act (No. 2) 1994-95*.

2. COMMENCEMENT

This Act shall come into operation on a date to be fixed by the Administrator by notice in the *Gazette*.

3. ALLOCATIONS AND APPLICATION OF \$2,289,942,000

(1) Allocations of the public moneys of the Territory, amounting in aggregate to \$2,289,942,000, are available for expenditure on the Activities specified in the Schedule in respect of the year ending on the expiration of 30 June 1995.

(2) The Allocations referred to in subsection (1) shall be deemed to have been available for expenditure on the Activities specified in the Schedule from and including 1 July 1994.

(3) Any amount issued out of the Consolidated Fund and applied for an Activity pursuant to the *Appropriation Act 1994-95* is included in the Allocations referred to in subsection (1) and is not in addition to those Allocations.
