AN ACT

to appropriate certain sums out of the Consolidated Fund
for the service of the year ending 30 June 1995

[Assented to 30 June 1994]

BE it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the *Northern Territory (Self-Government) Act 1978* of the Commonwealth, as follows:

1. SHORT TITLE

This Act may be cited as the *Appropriation Act 1994-95*.

2. COMMENCEMENT

This Act shall come into operation on 1 July 1994.

3. ISSUE AND APPLICATION OF \$1 325 430 000

(1) The Treasurer may issue out of the Consolidated Fund and apply for the activities specified in the Schedule in respect of the financial year ending 30 June 1995, the sum of \$1 325 430 000.

(2) The Consolidated Fund is appropriated to the extent necessary for the purposes of subsection (1).
