# AN ACT

to amend various Acts consequential on the passing of the Planning Act 1993

[Assented to 31 December 1993]

**B**<sup>E</sup> it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the Northern Territory (Self-Government) Act 1978 of the Commonwealth, as follows:

#### 1. SHORT TITLE

This Act may be cited as the Planning (Consequential Amendments) Act 1993.

#### 2. COMMENCEMENT

This Act shall come into operation on the commencement of the *Planning Act 1993*.

#### AMENDMENTS

- (1) The provisions of the Acts specified in Schedule 1 are amended as provided for in that Schedule.
- (2) The provisions of the Regulations specified in Schedule 2 are amended as provided for in that Schedule.
