## AN ACT

to amend the various Acts consequential on the passing of the *Public Sector Employment and Management Act 1993*

[Assented to 30 June 1993]

**B**E it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the *Northern Territory (Self-Government) Act 1978* of the Commonwealth, as follows:

### 1. SHORT TITLE

This Act may be cited as the *Public Sector Employment and Management (Consequential Amendment) Act 1993*.

### 2. COMMENCEMENT

This Act shall come into operation on the commencement of the *Public Sector Employment and Management Act 1993*.

### 3. AMENDMENTS

(1) The provisions of the Acts specified in Schedule 1 are amended as provided for in that Schedule.

(2) The provisions of the Regulations or Rules specified in Schedule 2 are amended as provided for in that Schedule.
