Act No. 20 of 2019

An Act to authorise an amount to be paid from the Central Holding Authority for the financial year ending 30 June 2020

> [Assented to 21 June 2019] [Introduced 7 May 2019]

The Legislative Assembly of the Northern Territory enacts as follows:

1 Short title

This Act may be cited as the Appropriation (2019-2020) Act 2019.

2 Commencement

This Act commences on the day on which the Administrator's Assent to this Act is declared.

3 Appropriation

- (1) An amount in aggregate of \$6 287 379 000 is authorised to be paid from the Central Holding Authority for the financial year ending 30 June 2020.
- (2) The amount is authorised to be paid to each Purpose of an Agency that is specified in column 1 of the Schedule, in the amount specified in the corresponding entry of column 2 of the Schedule.

4 Repeal of Act

This Act is repealed on 1 July 2020.
