No. 39 of 1992

AN ACT

to amend various Acts consequential on the
passing of the *Pastoral Land Act 1992*

[Assented to 25 June 1992]

BE it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the *Northern Territory (Self-Government) Act 1978* of the Commonwealth, as follows:

1. SHORT TITLE

This Act may be cited as the *Pastoral Land (Consequential Amendments) Act 1992*.

2. COMMENCEMENT

This Act shall come into operation or shall be deemed to have come into operation on the commencement of the *Pastoral Land Act 1992*.

3. AMENDMENTS

The provisions of the Acts specified in the Schedule are amended as provided for in that Schedule.
