# AN ACT

to amend the Totalizator Administration and Betting Act

[Assented to 3 June 1991]

BE it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the Northern Territory (Self-Government) Act 1978 of the Commonwealth, as follows:

# 1. SHORT TITLE

This Act may be cited as the Totalizator Administration and Betting Amendment Act 1991.

#### COMMENCEMENT

This Act shall come into operation on 1 July 1991.

#### PRINCIPAL ACT

The Totalizator Administration and Betting Act is in this Act referred to as the Principal Act.

## 4. LONG TITLE

The long title to the Principal Act is amended by omitting "to provide for the establishment of a Northern Territory Totalizator Administration Board,".

### 5. DEFINITIONS

Section 4 of the Principal Act is amended -

- (a) by omitting from the definition of "accounting period" the words "by the Board";
- (b) by omitting from the definition of "agency" the word "Board" (twice occurring) and substituting "Commission";

- (c) by omitting the definitions of "Board" and
   "Chairman" and substituting the following:
  - "'Chairman' means the Chairman of the Commission, and includes a person appointed to act as Chairman while so acting;";
- (d) by inserting after the definition of "club" the following:
  - "'Commission' means the Racing Commission established by the Racing Commission Act;"; and
- (e) by omitting from the definitions of "credit account", "member", "office" and "totalizator ticket" the word "Board" (wherever occurring) and substituting "Commission".

#### 6. HEADING TO PART II

The Principal Act is amended by omitting the heading to Part II and substituting the following:

"PART II - FUNCTIONS AND POWERS OF COMMISSION".

### 7. FURTHER AMENDMENTS

The Principal Act is further amended as provided for in the Schedule.
