



NORTHERN TERRITORY OF AUSTRALIA

No. 31 of 1988

AN ACT

to amend the *Soccer Football Pools Act*

[Assented to 14 September 1988]

BE it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the *Northern Territory (Self-Government) Act 1978* of the Commonwealth, as follows:

1. SHORT TITLE

This Act may be cited as the *Soccer Football Pools Amendment Act 1988*.

2. COMMENCEMENT

(1) This Act (other than section 4) shall come into operation on a date to be fixed by the Administrator by notice in the *Gazette*.

(2) Section 4 shall be deemed to have come into operation on 20 April 1986.

3. PRINCIPAL ACT

In this Act the *Soccer Football Pools Act* is referred to as the Principal Act.

4. APPLICATION OF SUBSCRIPTIONS

Section 19(1) of the Principal Act is amended by omitting paragraph (b) and substituting the following:

"(b) subject to section 20(2), pay to the Minister as duty an amount equal to -

(i) where in a financial year total subscriptions to soccer football pools held in that year are not more than \$104,000,000 and have never been more than \$104,000,000 in any preceding financial year and -

(A) total subscriptions to the pool do not exceed \$1,000,000 -

$0.34 \times T$; or

(B) total subscriptions to the pool exceed \$1,000,000 -

$0.34 \times T + 0.01 \times T \times \frac{(N - 1,000,000)}{N}$; and

(ii) in all other cases - $0.35 \times T$,

where -

T = the amount subscribed in the Territory to the pool; and

N = total subscriptions to the pool."

5. AGREEMENTS

Section 20 of the Principal Act is amended by omitting subsection (2) and substituting the following:

"(2) Where an agreement referred to in subsection (1)(b) provides for the exclusion of subscriptions by reference to which the amount of duty under section 19(1)(b) is to be calculated, the amount of duty to be paid by the licensee under that section shall be calculated on the subscriptions that are not specified by the agreement as being excluded."

6. FURTHER AMENDMENTS

The Principal Act is further amended as set out in the Schedule.
