



NORTHERN TERRITORY OF AUSTRALIA

No. 22 of 1987

AN ACT

to amend the *Water Supply and Sewerage Act*

[Assented to 25 June, 1987]

BE it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the *Northern Territory (Self-Government) Act 1978* of the Commonwealth, as follows:

1. SHORT TITLE

This Act may be cited as the *Water Supply and Sewerage Amendment Act 1987*.

2. COMMENCEMENT

(1) Sections 1 and 2 shall come into operation on the day on which the Administrator's assent to this Act is declared.

(2) The remaining provisions of this Act shall come into operation on the commencement of the *Power and Water Authority Act 1987* (other than sections 1 and 2 of that Act).

3. PRINCIPAL ACT

The *Water Supply and Sewerage Act* is in this Act referred to as the Principal Act.

4. INTERPRETATION

Section 6(1) of the Principal Act is amended -

- (a) by omitting from the definition of "approved" the word "Director" and substituting "Authority";
 - (b) by omitting the definition of "Director";
 - (c) by omitting from the definition of "main" the word "Territory's" and substituting "Authority's"; and

- (d) by inserting after the definition of "owner" the following:

"'Power and Water Authority' or 'Authority' means the Power and Water Authority established under section (4) of the *Power and Water Authority Act* and includes its delegate or agent;"

5. REPEALS

Sections 7, 8, 75A, 75B and 75C of the Principal Act are repealed.

6. AMENDMENTS

The Principal Act is amended in the manner specified in the Schedule.
