

## NORTHERN TERRITORY OF AUSTRALIA

# AN ACT

to amend the Electricity Commission Act

[Assented to 25 June, 1987]

**B**E it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the Northern Territory (Self-Government) Act 1978 of the Commonwealth, as follows:

#### 1. SHORT TITLE

This Act may be cited as the *Electricity Commission* Amendment Act 1987.

#### 2. COMMENCEMENT

- (1) Sections 1 and 2 shall come into operation on the day on which the Administrator's assent to this Act is declared.
- (2) The remaining provisions of this Act shall come into operation on the commencement of the *Power and Water Authority Act 1987* (other than sections 1 and 2 of that Act).

#### 3. PRINCIPAL ACT

The *Electricity Commission Act* is in this Act referred to as the Principal Act.

#### 4. LONG TITLE

The long title to the Principal Act is amended by omitting "to establish a Northern Territory Electricity Commission and" and ", sale".

#### 5. CITATION

The Principal Act as amended by this Act may be cited as the *Electricity Act*.

#### Electricity Commission Amendment

#### 6. DEFINITIONS

Section 3 of the Principal Act is amended -

- (a) by inserting before the definition of "Chairman" the following:
- "'Authority' means the Power and Water Authority established by section 4 of the Power and Water Authority Act;";
- (b) by omitting the definition of "Chairman" and substituting the following:
- "'Chairman' means the Chairman of the Authority and includes, when acting as Chairman, the Deputy Chairman;";
- (c) by omitting the definition of "Commission";
- (d) by omitting the definition of "employee" and substituting the following:
- "'employee' means an employee of the Authority, and includes -
  - (a) an employee of the Northern Territory Electricity Commission as at the commencement of the Electricity Commission Amendment Act 1987 (including a transferred employee within the meaning of Part VIA of the Public Service Act); and
  - (b) a transferred or transferable employee within the meaning of Part VIB of the Public Service Act;"; and
- (e) by omitting from the definition of "licensee" the word "Commission" and substituting "Authority".

## 7. REPEALS

The following provisions of the Principal Act are repealed:

Part II (other than section 14(4) and (5) and sections 15 and 16), section 26(1)(a), (b) and (d) and sections 31A, 33, 34, 35, 36 and 37.

### 8. AMENDMENT

The Principal Act (as amended by sections 4, 6 and 7 of this Act) is amended by omitting "Commission" wherever it may appear and substituting in each case "Authority".
