AN ACT

to amend the Darwin Port Authority Act

[Assented to 30 December 1986]

BE it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the Northern Territory (Self-Government) Act 1978 of the Commonwealth, as follows:

1. SHORT TITLE

This Act may be cited as the Darwin Port Authority Amendment Act 1986.

2. SCHEDULE 1

17. ×2-9-18-44

Schedule 1 of the *Darwin Port Authority Act* is amended by omitting all words after and including "with the northern boundary of Lot 5236 Town of Darwin" to and including "thence westerly by part of the said northerly boundary of the said Lot to the northwestern corner of the said Lot" and substituting the following:

"with the southern boundary of Lot 5236 Town of Darwin; thence westerly, northerly by the southern and western boundaries of the said Lot to the northwestern corner of the said Lot; thence northerly by the western boundary of Lot 5014 Town of Darwin to the northwestern corner of the said Lot; thence northerly by the western boundary of Lot 5195 Town of Darwin to the southwestern corner of Lot 5276 Town of Darwin; thence by lines on grid bearings 99° 56' 20" for 155.165 m; thence 9° 56' 20" for 50 m; thence 99° 56' 20" for 50 m; thence 279° 56' 20" for 50 m; thence by a line bearing 9° 56' 20" to its intersection with the high-water mark of Frances Bay; thence generally northerly by the said high-water mark to its intersection with the northern boundary of Lot 5276 Town of Darwin; thence westerly by the northern boundary of the said Lot and Lot 5377 Town of Darwin to the northwestern corner of Lot 5377; thence by

lines on grid bearings 189° 56' 20" for 150 m; thence 270° to the intersection with the eastern boundary of the realigned Frances Bay Drive Road Reserve; thence generally northwesterly, northerly, northeasterly by the said road reserve boundary to its intersection with the westerly prolongation of the southern boundary of Lot 5370 Town of Darwin; thence easterly by said prolongation to the southwestern corner of Lot 5370 Town of Darwin; thence southerly by the western boundaries of Lots 5371, 5372, 5373, 5374 and 5375 Town of Darwin to the northwestern corner of Lot 5376 Town of Darwin; thence easterly by the northern boundary of the said Lot and Lot 5275 Town of Darwin to its intersection with the high-water mark of Frances Bay; thence generally northerly by the said high-water mark to its intersection with the southern boundary of Lot 5270 Town of Darwin; thence easterly and northerly by the southern and eastern boundaries of Lot 5270 Town of Darwin to the northeastern corner of the said Lot; thence northerly and westerly by the eastern and northern boundaries of Lot 5269 Town of Darwin to the northwestern corner of the said Lot".
