

# NORTHERN TERRITORY OF AUSTRALIA

No. 31 of 1986

# AN ACT

to amend the Northern Territory Tourist Commission Act

[Assented to 19 September 1986]

BE it enacted by the Legislative Assembly of the Northern Territory of Australia with the assent as provided in the Northern Territory of **D** Australia, with the assent as provided by the Northern Territory (Self-Government) Act 1978 of the Commonwealth, as follows:

#### SHORT TITLE 1.

This Act may be cited as the Northern Territory Tourist Commission Amendment Act 1986.

#### 2. PRINCIPAL ACT

The Northern Territory Tourist Commission Act is in this Act referred to as the Principal Act.

#### 3. DEFINITIONS

Section 4 of the Principal Act is amended -

- (a) by inserting after the definition of "Chairman" the following:
- "Chief Executive Officer" means the Chief Executive Officer appointed under section 20A and includes a person appointed under section 20B to act as the Chief Executive Officer while he is so acting; and
- by omitting the definition of "public servant".

#### COMPOSITION OF COMMISSION

Section 6 of the Principal Act is amended by omitting subsection (1) and substituting the following:

"(1) The Commission shall consist of the Chief Executive Officer and not more than 4 other members."

### 5. PERIOD OF APPOINTMENT

Section 7 of the Principal Act is amended by omitting from subsections (1) and (2) "a public servant" and substituting "the Chief Executive Officer".

#### 6. CHAIRMAN

Section 8 of the Principal Act is amended -

- (a) by omitting from subsection (1) "and who is a public servant"; and
- (b) by omitting from subsection (3) "vacancy,".

### 7. RESIGNATION

Section 11 of the Principal Act is amended by omitting "who is not a public servant".

#### 8. DISMISSAL

Section 12(1) of the Principal Act is amended by omitting "a public servant" and substituting "the Chief Executive Officer".

#### ACTING APPOINTMENTS

Section 13(1) of the Principal Act is amended by omitting "public servant" and substituting "Chief Executive Officer".

#### 10. MEETINGS OF COMMISSION

Section 15(2)(a) of the Principal Act is amended by omitting "2 members" and substituting "3 members".

## 11. NEW SECTION

The Principal Act is amended by inserting after section 20 the following:

# "20A. CHIEF EXECUTIVE OFFICER

- "(1) The Minister may, by instrument in writing, appoint a person to be the Chief Executive Officer of the Commission.
- "(2) The Minister may at any time terminate the appointment of the Chief Executive Officer.
- "(3) Subject to this section the Chief Executive Officer shall hold office on such terms and conditions as are determined by the Administrator.

## Northern Territory Tourist Commission Amendment

- "(4) Where immediately before his appointment as Chief Executive Officer a person was an employee within the meaning of the *Public Service Act*, the terms and conditions of his appointment as Chief Executive Officer shall, subject to subsection (2), be not less favourable than those then applicable to him.
- "(5) The Chief Executive Officer shall be charged with carrying out the decisions of the Commission.

## "20B. ACTING CHIEF EXECUTIVE OFFICER

- "(1) The Minister may appoint a person to act from time to time as the Chief Executive Officer during the absence from duty or from the Territory of the Chief Executive Officer or a vacancy in the office of Chief Executive Officer.
- "(2) The Minister may at any time terminate an appointment made under subsection (1).".

### 12. STAFF

Section 21(3) of the Principal Act is amended by omitting "Chairman" and substituting "Chief Executive Officer".
