No. 18 of 1986

AN ACT

to make amendments to certain Acts as a consequence of the Territory becoming a party to the National Companies and Securities Scheme

[Assented to 30 June 1986] B E it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the Northern Territory (Self-Government) Act 1978 of the Commonwealth, as follows:

1. SHORT TITLE

This Act may be cited as the Companies and Securities (Consequential Amendments) Act 1986.

2. COMMENCEMENT

This Act shall come into operation on 1 July 1986.

3. AMENDMENTS

The provisions of the Acts specified in the Schedule are amended as provided for in that Schedule.
