### AN ACT

To amend the *Education Act*  
[Assented to 12 December 1985]

**B**E it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the *Northern Territory (Self-Government) Act 1978* of the Commonwealth, as follows:

#### 1. SHORT TITLE

This Act may be cited as the *Education Amendment Act (No. 2) 1985*.

#### 2. COMMENCEMENT

This Act shall come into operation on the commencement of the *Advanced Education and Darwin Institute of Technology Act 1985*.

#### 3. PRINCIPAL ACT

The *Education Act* is in this Act referred to as the Principal Act.

#### 4. DEFINITIONS

Section 4 of the Principal Act is amended by inserting after the definition of "head teacher" the following:

"'Institute' has the same meaning as it has in the *Advanced Education and Darwin Institute of Technology Act*;"

5. COMPOSITION OF BOARD AND APPOINTMENT OF MEMBERS

Section 10C(2) of the Principal Act is amended -

- (a) by omitting from paragraph (b) "within the meaning of Part VI"; and
- (b) by omitting paragraph (c)(vi) and substituting the following:

"(vi) the Council within the meaning of the *University College of the Northern Territory Act*";

6. DISMISSAL OF MEMBERS

Section 10G(3)(b) of the Principal Act is amended by omitting "within the meaning of Part VI".

7. ESTABLISHMENT AND COMPOSITION

Section 16 of the Principal Act is amended -

- (a) by omitting from subsection (2)(d) "within the meaning of Part VI" and substituting "of the Institute";
- (b) by omitting from subsection (3)(a) "Part VI" and substituting "*the Advanced Education and Darwin Institute of Technology Act*"; and
- (c) by omitting from subsection (4) "within the meaning of Part VI" and substituting "of the Institute".

8. DISMISSAL

Section 18B(3)(a) of the Principal Act is amended by omitting "Part VI" and substituting "*the Advanced Education and Darwin Institute of Technology Act*".

9. GENERAL POWER TO ESTABLISH ADVISORY COUNCILS

Section 19(4) of the Principal Act is amended by omitting "Part VI" and substituting "*the Advanced Education and Darwin Institute of Technology Act*".

10. REPEAL

Part VI of the Principal Act is repealed.

11. DEFINITIONS

Section 61 of the Principal Act is amended by omitting from paragraph (c) of the definition of "educational institution" the words "within the meaning of Part VI".

12. GENERAL POWERS OF SECRETARY

Section 69(4) of the Principal Act is amended by omitting "within the meaning of Part VI" and substituting "or to the College established by the *University College of the Northern Territory Act*".
