## NORTHERN TERRITORY OF AUSTRALIA

### AN ACT

To revise and correct the law of the Territory  
in minor respects

[Assented to 1 October 1985]

**B**E it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the *Northern Territory (Self-Government) Act 1978* of the Commonwealth, as follows:

1. SHORT TITLE

This Act may be cited as the *Statute Law Revision Act 1985*.

2. REPEAL OF CERTAIN ACTS

The *Building Ordinance 1961* (No. 9 of 1962), the *Building Act 1979* (No. 54 of 1979) and the *Explosives Amendment Act 1980* (No. 2 of 1981) are repealed.

3. AMENDMENTS TO CERTAIN REGULATIONS

(1) Regulation 27A of the Marine (Seamen) Regulations made under the *Marine Act* is amended by omitting "27A" and substituting "17A".

(2) Regulation 50 of the Fish and Fisheries Regulations made under the *Fish and Fisheries Act* is amended by omitting "50" and substituting "47".

(3) Regulation 46A of the Traffic Regulations made under the *Traffic Act* is amended by omitting "21(1), 28,".

(4) Regulation 87A of the Motor Omnibus Regulations made under the *Motor Vehicles Act* is amended by omitting "83" and substituting "83(2)".
