NORTHERN TERRITORY OF AUSTRALIA

No. 58 of 1983

AN ACT

To revise and correct the law of the Territory
in minor respects

[Assented to 28 November 1983]

BE it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the *Northern Territory (Self-Government) Act 1978* of the Commonwealth, as follows:

1. SHORT TITLE

This Act may be cited as the *Statute Law Revision Act 1983*.

2. REPEAL

The *Housing Act 1980* (No. 43 of 1980), the *Housing Amendment Act (No. 2) 1980* (No. 8 of 1981) and the *Housing Amendment Act 1981* (No. 47 of 1981) are repealed.

3. PLACES OF PUBLIC ENTERTAINMENT REGULATIONS (No. 24 OF 1983)

(1) Regulation 2 of the Places of Public Entertainment Regulations (No. 24 of 1983) made under the *Places of Public Entertainment Act* is amended by omitting "Act (No. 2)" and substituting "*Amendment Act*".

(2) Sub-regulation (1) shall be deemed to have come into operation on 26 August 1983.

4. STATUTE LAW REVISION

The provisions of the Acts specified in the Schedule are amended as provided for in the Schedule.
