



NORTHERN TERRITORY OF AUSTRALIA

No. 23 of 1983

AN ACT

To amend the *Territory Parks and Wildlife Conservation Act*

[Assented to 24 June 1983]

BE it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the *Northern Territory (Self-Government) Act 1978* of the Commonwealth, as follows:

1. SHORT TITLE

This Act may be cited as the *Territory Parks and Wildlife Conservation Amendment Act (No. 2) 1983*.

2. PRINCIPAL ACT

The *Territory Parks and Wildlife Conservation Act* is in this Act referred to as the Principal Act.

3. INTERPRETATION

Section 9 of the Principal Act is amended by omitting from sub-section (1) -

- (a) the definition of "By-laws";
- (b) from the definition of "Place Names Committee" the words "*Place Names Ordinance*" and substituting "*Place Names Act*";
- (c) the definition of "Regulations";
- (d) the definition of "this Ordinance" and substituting the following:
"this Act" includes the Regulations;"; and
- (e) "Ordinance" (wherever occurring) and substituting "Act".

4. KILLING OF PROTECTED ANIMAL

Section 29 of the Principal Act is amended -

(a) by omitting from sub-section (1) -

- (i) "Ordinance" (first occurring) and substituting "Act";
- (ii) "Ordinance." (second occurring) and substituting "Act or a notice under sub-section (3).";
- (iii) "2000 dollars" and substituting "\$2,000"; and
- (iv) "100 dollars" and substituting "\$100"; and

(b) by adding at the end the following:

"(3) The Minister may, by notice in the Gazette, declare that it is lawful to kill a protected animal and may specify -

- (a) the period during which (including the times at which) a protected animal may be killed;
- (b) the areas where a protected animal may be killed;
- (c) the type of equipment which may be used for the purposes of killing a protected animal;
- (d) the maximum number of protected animals which a person may kill during a specified period;
- (e) the maximum number of dead protected animals or parts of dead protected animals which a person may have in his possession or under his control; and
- (f) such other condition or matter, as the Minister thinks fit.

"(4) A declaration, by notice under sub-section (3), does not authorize the killing of an animal in a park, reserve, sanctuary, wilderness zone or protected area."

5. PARTS OF PROTECTED ANIMAL

Section 31 of the Principal Act is amended by omitting -

(a) from sub-section (1) -

- (i) "Ordinance" (twice occurring) and substituting "Act";

- (ii) "2000 dollars" and substituting "\$2,000";
and
 - (iii) "100 dollars" and substituting "\$100";
 - (b) from sub-section (2) "Ordinance." and substituting "Act or a notice under section 29(3)."; and
 - (c) from sub-section (3) "Ordinance" and substituting "Act or a notice under section 29(3)".
6. REPEAL

Section 72 of the Principal Act is repealed.

7. FURTHER AMENDMENTS

The Principal Act is further amended as set out in the Schedule.
