NORTHERN TERRITORY OF AUSTRALIA

No. 54 of 1982

AN ACT

To revise and correct the law of the
Territory in minor respects

[Assented to 8 October 1982]

BE it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the *Northern Territory (Self-Government) Act 1978* of the Commonwealth, as follows:

1. SHORT TITLE

This Act may be cited as the *Statute Law Revision Act (No. 2)* 1982.

2. STATUTE LAW REVISION

The provisions of the Acts specified in the Schedule are amended as provided for in the Schedule.
