NORTHERN TERRITORY OF AUSTRALIA

No. 4 of 1982

AN ACT

To revise and correct the law of the Territory in minor respects
[Assented to 12 February 1982]

BE it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the *Northern Territory (Self-Government) Act 1978* of the Commonwealth, as follows:

1. SHORT TITLE

This Act may be cited as the Statute Law Revision Act (No. 4) 1981.

2. REPEAL

(1) The Mines Regulation Act 1978 (No. 66 of 1978) and the Leprosy Amendment Act 1980 (No. 1 of 1981) are repealed.

(2) The Innkeepers Act, 1888 (No. 432 of 1888) of the State of South Australia, in its application to the Territory as a law of the Territory, is repealed.

3. STATUTE LAW REVISION

The provisions of the Acts specified in the Schedule are amended as provided for in the Schedule.
