NORTHERN TERRITORY OF AUSTRALIA

No. 63 of 1981

AN ACT

To revise and correct the law of the Territory in minor respects
[Assented to 20 July 1981]

BE it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the *Northern Territory (Self-Government) Act 1978* of the Commonwealth, as follows:

1. SHORT TITLE

This Act may be cited as the Statute Law Revision Act (No. 2) 1981.

2. STATUTE LAW REVISION

The provisions of the Acts specified in the Schedule are amended as set out in the Schedule.
