THE NORTHERN TERRITORY OF AUSTRALIA

AN ACT

To revise and correct the law of the Territory in minor respects

[Assented to 25 March 1981]

B^E it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the Northern Territory (Self-Government) Act 1978 of the Commonwealth, as follows:

SHORT TITLE

This Act may be cited as the Statute Law Revision Act 1981.

2. STATUTE LAW REVISION

The provisions of the Acts specified in Column 1 of Schedule 1 are respectively amended as provided in Column 2 of that Schedule.

3. REPEAL

The Acts specified in Schedule 2 are repealed.
