AN ACT

To amend the Nursing Act

[Assented to 25 March 1981]

- **B**^E it enacted by the Legislative Assembly of the Northern Territory of Australia, with the assent as provided by the Northern Territory (Self-Government) Act 1978 of the Commonwealth, as follows:
 - 1. SHORT TITLE

This Act may be cited as the Nursing Amendment Act 1981.

2. PRINCIPAL ACT

The Nursing Act is in this Act referred to as the Principal Act.

3. CONSTITUTION OF NURSES BOARD

Section 5 of the Principal Act is amended by omitting paragraphs (a) to (c) inclusive and substituting the following:

- "(a) the registered nurse responsible to the Chief Medical Officer for nursing services in the Territory;
- (b) the person appointed under section 15 of the <u>Hospitals and</u> <u>Medical Services Act</u> to be, for the time being, in charge of the Casuarina Hospital;
- (c) the registered nurse in charge of nursing services at the Alice Springs Hospital; and".
- 4. MEETINGS OF BOARD

Section 6 of the Principal Act is amended by omitting subsection (1) and substituting the following:

"(1) The registered nurse responsible to the Chief Medical Officer for nursing services in the Territory shall be the Chairman of the Board.".
